## INSTRUCTIONS TO CONTRIBUTORS

### General information

*The Neurodiagnostic Journal* (formerly published as the *American Journal of Electroneurodiagnostic Technology*) welcomes original manuscripts related to the science, technology, and practice of neurodiagnostics. Published papers include topics in the areas of EEG, evoked potentials, intraoperative neuromonitoring, long-term monitoring, nerve conduction studies, and polysomnography. Research articles, case reports, review articles, and technique articles are published in *The Neurodiagnostic Journal*.

Manuscripts are subject to a peer-review process to determine originality, validity, and importance of content and conclusions. Authors will be advised of the decision usually within four to six weeks. All reviewers will remain anonymous.

Authors are responsible for obtaining written permission from the original copyright holder to publish previously published figures and tables. Published papers are copyrighted by ASET – The Neurodiagnostic Society and may not be published elsewhere without permission.

ASET Continuing Education (ASET-CEU) credits are awarded to the authors when the manuscript is published.

### Publication categories

**Research article** is a report of an original investigation or study. A research article includes an Abstract, Key Words, Introduction, Methods, Results, and Discussion.

**Case report** is a report of a clinical case that is unique, was managed in a new way, or is instructive. All authors must be associated with the case. A case report includes an Abstract, Key Words, Introduction, Case Summary, and Discussion.

**Review article** is a comprehensive, critical review of the literature and a state-of-the-art summary of a pertinent topic that has been the subject of at least 40 published research articles. A review article includes an Abstract, Key Words, Introduction, Review of the Literature, and Summary.

**Technique article** is a “Technical Tips” feature article that describes a new technique or explains a well-established technique. Technical Tips articles may express personal opinions.

**Letter** is a signed communication about prior publications in *The Neurodiagnostic Journal* or about other pertinent topics.

**Media review** is a critical review of a recently published printed or digital material. The media reviewer receives continuing education credits for writing the review and keeps the printed or digital material in his/her personal library.

## Preparing the Manuscript

**Electronic submission** of the manuscript is strongly encouraged. If you are unable to submit electronically, you must send a diskette copy of the manuscript along with the original and five hard copies.

Use Times New Roman font size 12. All material must be double-spaced with a margin of at least 2.5 cm (1 inch) on all sides. Do not justify.

An abstract, not exceeding 200 words, should precede the main body of the manuscript. A list of key words, in alphabetical order, should follow the abstract. The body of the manuscript should be divided into logically organized sections, with headings and subheadings clearly delineated.

All acknowledgements, including supporting grants, should appear between the body of the paper and the references. Grant support should include the full name of the granting agency and grant number. Pharmaceutical company or other industry support must be acknowledged.

**Tables and Figures.** All tables and figures must be cited in the text and numbered with Arabic numerals. Each table and figure should have an explanatory legend. All abbreviations and symbols must be explained in the legend.

Illustrations should be submitted as PDF (preferred), TIF, or EPS files at 1200 dpi. EEG and evoked potential waveforms must include a calibration bar. The digital figures should be the final size desired. Color illustrations can be used but the author will have to cover part of the cost. Consult the Managing Editor about color figures.

**Permissions.** It is the responsibility of the author to secure written permission to use **copyrighted material**. Send all letters granting reprint permission to the Managing Editor. In the legend of the reproduced material, give full credit to the original source and cite the reference. Photographs of identifiable persons or identifiable case study reports must be accompanied by signed releases showing informed consent.

**Abbreviations and Drug Names.** Any abbreviation used, except EEG, should be spelled out at their first use in the text. The abbreviation should be used consistently thereafter. It is better to use the entire term than to abbreviate terms and expressions not commonly abbreviated. Use generic name in referring to drugs. A trade name may be given in parentheses the first time the name is used, but the generic name should be used thereafter.

**References.** The accuracy of the references is the responsibility of the author. References should be cited in the text by the name of author(s) and year of publication. No comma separates the author from the year (Frye 2004). If there are more than two authors, use the first author followed by et al. (Hecimovic et al. 2001).

Journal titles should be abbreviated according to the abbreviations approved by *Index Medicus*. Arrange references in strict alphabetical order by the first author. Chronological order should only be used only in the case of multiple articles published by the same author in the same year. If published in the same year, use a, b, etc., after the

year. All authors should be included in the reference list; et al. is not acceptable in the reference list.

**Proofs and reprints.** Each first author (including authors of book reviews) will receive first page proofs and reprint order sheets directly from the publisher. Authors are asked to check the proof very carefully, especially the reference data, and return it to the Managing Editor within three days of receipt.

**Copyright.** Copyright on all articles published in *The Neurodiagnostic Journal* will be held by ASET – The Neurodiagnostic Society. All authors must sign a statement expressly transferring copyright to ASET.
